Join members of the Institutional Effectiveness & Analytics team at Ohio University to hear about how we developed an informative and functional COVID-19 dashboard from the ground up. We'll discuss our process from the beginning to (maybe never) the end.</p> <p style="text-align: center;">Registration Link</p>	<p>Session 1.B : Using ODJFS Unemployment Insurance (UI) Wage Record Data: Building a Vision and Methodology</p> <p>Presenter: <i>Laura Wittel, Paul Rusinko, Kat McDonald-Miranda, Columbus State Community College</i></p> <p>Description: Many institutions of higher education have expressed interest in utilizing labor market data to investigate the impact of students' higher education on their employment and wages. This new avenue for institutional research requires the development of a vision, methodology, and plan to move forward. Columbus State Community College recently began collecting data from the Ohio Department of Job and Family Services to assess the impact of achieving the Associate Degree milestone on immediate graduate employment rates and wages. <p style="text-align: center;">1:45 PM – 2:30 PM</p>	<p>WORKSHOP 2.C : Build your own Text Analysis Pipeline in Python (No Coding Skills Required)</p> <p>~ WORKSHOP BEGINS @ 1:30 PM – 2:40 PM ~</p> <p>Presenter: <i>Kevin Chang, Kai Analytics and Survey Research Incorporated</i></p> <p>Description: Whether it's student satisfaction, campus climate, or alumni surveys, analyzing open-ended comments can be daunting! This workshop explores essential text analytics concepts in Natural Language Processing (NLP) and linguistics, focusing on detailed hands-on examples for higher education. No coding experience is required. All hands-on activities will use pre-written Python code available in the online platform Google CoLab, and will focus on analyzing and visualizing over 1,200 Coursera course reviews. CoLab was developed to make statistical computing and machine learning more accessible for researchers. It provides a Jupyter Notebook (web-based) environment requiring no setup, runs entirely in the cloud, and only requires a web browser to use. However, participants will need a Google account to access CoLab. All example code will also be made publicly available after the workshop.</p> <p style="text-align: center;">Registration Link</p>	<p>Session 2.D : Building A Data Science Capacity</p> <p>Presenter: <i>Dr. Craig Rudick, HelioCampus, Inc.</i></p> <p>Description: Many institutions are looking to expand their data science and strategic decision support capabilities to facilitate key initiatives, such as growing enrollment, promoting student success, and planning for financial sustainability. This presentation will focus on practical tips and lessons learned for building data science programs at higher education institutions. By reviewing all aspects of the data science process, including software and tools, personnel and skill sets, and (perhaps most importantly) communication and institutional culture, attendees will better understand how to embark on this journey. We will show examples of successful data science projects, and discuss the institutional decision-making that these facilitated. <p style="text-align: center;">2:45 PM – 3:30 PM</p>	<p>Session 3.E : Answering the Call for Better Data: The Postsecondary Data Partnership</p> <p>Presenter: <i>Ken McVeary, National Student Clearinghouse</i></p> <p>Description: The Postsecondary Data Partnership (PDP) empowers the nation's colleges and universities with better data and analytics that help institutions realize better outcomes for their students. The PDP provides institutions and systems with access to data which examines student momentum and success through an equity lens with two tools. By visualizing KPI information in dashboards on student enrollment, early momentum metrics, and student outcomes, schools can use filters that reveal barriers to equitable results. Data can be viewed by intersectional characteristics at once, including race/ethnicity, gender, Pell grant recipients, first generation students, age groups, and college level readiness in Math/English. Come learn, schools are embracing these metrics and acting upon them for meaningful change. The ability to distinguish and understand trends from the data is providing institutions the insights to assess their student success initiatives and effectively tell their success stories.</p> <p style="text-align: center;">Registration Link</p>	<p>Session 3.F : 2020-2022 Completion Plan Update from ODHE</p> <p>Presenter: <i>Dr. Stephanie Davidson, Ohio Department of Higher Education</i></p> <p>Description: Ohio's public institutions of higher education are required to develop a plan addressing student success every two years. These plans are known as institutional completion plans and the 2020-2022 updates are due to ODHE by December 1. Dr. Davidson will provide an overview of the legislation, expectations for institutions, and share examples of data informing planning for both the state and institutions. <p style="text-align: center;">3:45 PM – 4:30 PM</p>	<p>Session 4.G : Navigating the New Normal: How COVID-19 Impacted Experiential Education</p> <p>Presenter: <i>Katie Brown & Chelsea Donovan, Northeast Ohio Medical University</i></p> <p>Description: Due to the COVID-19 pandemic, the College of Pharmacy at Northeast Ohio Medical University had to restructure its experiential education learning components to accommodate to life in the new normal. To adhere to accreditation and graduation requirements, the Office of Experiential Education adapted rotations because hospitals were unable to host students on-site. Rotations were transformed to virtual simulation, detailed case studies with group discussions, and video conferencing. To identify best methods, students completed an evaluation at the end of each rotation. Overall, students enjoyed their adapted experiences and felt that the new format was tailored to their education.
